IMPORTANT NOTICE TO THE SHIPPERS

If the same is not received 5 business days prior to the sailing of the cargo, the same will be kept on hold at the port of loading and whichever storage/demurrage charges accrued because of these actions will be for the account of shipper.

Hitech Courier is not responsible for breakages/damages or dents on consolidated items/cars for any negligence at point of unloading or destination. If cargo sailed and the ocean freight has not been paid for 5 days prior to the arrival of the same at the port of final destination, please be advised that HITECH COURIER LLC, will have no alternative but to exercise its lien rights and have the cargo sold. If there are any funds remaining after the freight payment has been satisfied, they will be returned to the shipper.

The carrier, forwarder, or its agents are not responsible for personal effects placed inside the vehicle. All vehicles must be in good drivable condition. Ocean freight rates, sailings and vessels are subject to change. All charges are pre-paid. Misrepresentation is punishable by law.
